

Pupil Premium Strategy 2020/2021: *Gentleshaw Primary Academy*



1. Summary Information

The Department of Education categorises disadvantaged pupils as:

- Pupils in Year Groups Reception to 6 recorded as Ever 6 FSM this means those pupils recorded on the January School Census known to be eligible for Free School Meals (FSM)
- Looked After Children (LAC)
- Children adopted from care under the Adoption and Children Act 2002
- Children of armed forces personnel

At Gentleshaw Primary Academy, all members of staff and governors accept responsibility for 'socially disadvantaged' pupils and are committed to narrowing the gap in their attainment.

3. Barriers to Attainment for Pupil Premium Pupils

- Due COVID 19 and the school closures Pupil Premium Pupils have missed a significant amount of their education. PP families were offered time for their children to attend school during the closure but only 2 out of the 12 families accepted this.
- A high proportion of the Pupil Premium Pupils have specific learning and/or behavioural needs, which affect academic progress and attainment. 42% of Pupil Premium Pupils are on the SEN Register or 'On Watch'.
- Pupil Premium Pupils are not attaining as well as other pupils in reading, writing and maths.
- Cost can be a barrier and reduces the opportunity/financial resources for extra-curricular & enrichment activities such additional clubs; visits and residential trips.
- A number of Pupil Premium pupils have social and emotional issues and as a result receive support from in school and outside agencies. In some instances, this adversely impacts upon aspirations and self-esteem, learning behaviours, progress and attainment.
- The attendance of Pupil Premium Pupils is less than that of non-pupil premium pupils with punctuality being an issue amongst some Pupil Premium Pupils.
